**SCHEDULE IRR TOU  
IRRIGATION SERVICE EFFECTIVE JUNE 1, 2015**

**AVAILABILITY**

This time-of-use (TOU) rate is used to bill irrigation services. Whitewater Valley Rural Electric Membership Corporation (REMC) shall charge and collect for irrigation service on the following basis of availability, application, character of service, monthly rate, minimum charge, rate adjustment clauses, and tax adjustment.

This schedule is available to any member of the REMC located within the territory served by Whitewater Valley REMC.

**TYPE OF SERVICE**

This schedule is applicable for all irrigation electric services required for lighting, power, and any other purpose with a 150 kW peak demand or less.

**ENERGY**

**On peak:**

On-Peak – For the months of June through August, excluding Independence Day as defined by the NERC holiday schedule, On-peak energy shall be all Kilowatt-hours used during the period 2:00 pm to 7:00 pm – Monday through Friday, E.D.T., daily.

For the months of December through February, excluding Christmas and New Years Day as defined by the NERC holiday schedule, On-peak energy shall be all kilowatt-hours used during the periods 7:00am to 10:00am and 6:00pm to 9:00pm – Monday through Friday, E.S.T. daily.

E.D.T. = Daylight Savings Time is -4 hours of the UTC (Coordinated Universal Time)

E.S.T. = Eastern Standard Time is -5 hours of the UTC (Coordinated Universal Time)

**Off Peak:**

Off-Peak energy shall be all kilowatt-hours used during all hours other than on-peak hours as described above.

**WHOLESALE POWER ADJUSTMENT**

The above rates are subject to a wholesale power adjustment clause as defined in Appendix “A”.

**MINIMUM (STAND BY) FACILITIES CHARGES**

The facilities charge and per KVA charge on the transformer capacity must be paid for twelve months of service per year. A single phase service will be billed a minimum of \$432.00 annually in facilities charges and the per KVA charge on the transformer capacity will vary depending on the size of equipment at the members location. A three phase service will be billed a minimum of \$552.00 annually in facilities charges and the per KVA charge on the transformer capacity will vary depending on the size of equipment at the members location. If service is not maintained for a twelve month period, this charge will be billed on the final bill after disconnection of service.

**TERMS AND CONDITIONS**

1. The applicant will be required to give satisfactory assurance in writing as to the character, amount, and duration of the service required.
2. In general, motors having a rated capacity greater than ten (10) horsepower must be three-phase. All motors shall have manufacturer’s nameplate specifying horsepower rating, voltage and other pertinent information.

**INTERRUPTION OF SERVICE**

The REMC will make reasonable provisions to ensure satisfactory and continuous service, but does not guarantee a continuous supply of electrical energy and shall not be liable for damage occasioned by interruptions of service or failure to commence delivery caused by an act of God, or the public enemy, or for any cause reasonably beyond its control, including but not limited to the failure or breakdown of generating or transmitting facilities, floods, fire, strikes, or action or order of any agency having jurisdiction in the premises, or for interruptions which are necessary for inspection, repair, or changes in the generating equipment or transmission and distribution system of the REMC.

The Member shall notify the REMC immediately of any defects, trouble, or accident, which may in any way affect the delivery of power by the REMC to the member.
